- 2. A new voluntary PAC Deduction (\$.05) that requires the Employee's authorization. The Union will supply this signed authorization to the Employer to begin the deduction.
- 3. The Savings Fund is now <u>voluntary</u> and requires a signed authorization which will be provided by the Union. The Employee may elect the Voluntary Savings Plan deduction after taxes of a minimum of one dollar and fifty cents (\$1.50) per hour or in increased increments of fifty cents (\$0.50) per hour.
