

### **GENERAL CONVENTION**

The United Association of Journeymen and Apprentices of the Plumbing and Pipe Fitting Industry of the United States and Canada's 39th General Convention in San Diego, California began on August 1st and ended Friday, August 5th. This convention takes place every five (5) years with the sole purpose of setting and/or updating standards, goals, and procedures. This year's union leaders were welcomed from around the United States, Canada, Australia, and Ireland, as well as contractors, project owners, and government officials. Local 130 is the 6th largest local in the entire UA and, therefore had 60 delegates in attendance.

On Monday afternoon, Business Manger Jim Coyne was privileged to speak on behalf of Local 130's participation in a "Hillary for Illinois" rally. Jim Coyne stated, "As a Senator, Hillary Clinton stood side by side with working Americans like our UA members. She has fought against anti-union and anti-worker legislation. Secretary Clinton is the only candidate running for President who was an original co-sponsor of the Employee Free Choice Act. She also has made our apprentice programs and training a priority in her campaign and protecting workers' retirement benefits. This is vital! Hillary Clinton wants our apprentices to fill the current and upcoming jobs in the construction industry and to become members of the Building Trades like every Brother and Sister in this UA. If you have reservations about voting for Hillary Clinton, remember that at their convention in Cleveland, the Republican Party made a key part of its platform by enacting a national Right-to-Work law. We cannot allow this to happen! We must go to the polls on November 8th and we must vote to elect Hillary Clinton as our next President."

Jim Coyne also addressed the delegates regarding apprentice voting. Business Manager Coyne stated, "The issue of apprentices voting has been a controversial subject for decades. I believe it is time for a positive and progressive change. At Local 130, we have over 600 apprentices. The average age is 28 years old. Since 2015 we brought on over 300 educated and intelligent new apprentices. There are apprentices who are military reservists and veterans. Many have made a career change. After three (3) years under my leadership, I believe I have done my job to prepare apprentices through education and being involved in the union movement at Local 130. Apprentices are Local 130's future leaders and these men and women should have a voice and a vote in their union."

On the last day of the convention, Jim Coyne addressed the delegation with comments about our General President, William P. Hite and his upcoming retirement. "If you recall, Bill was last year's St. Patrick Day Parade's Grand Marshal, our hometown hero. I wish Bill good luck, good health, and a wonderful retirement. He and his wife Pat have put in their time and deserve the best."

General President-Elect Mark McManus has challenged us, the leadership and members of this United Association, from the greatest to the least, with a new rally cry: To be an organization "Built on Excellence."



**Right-to-Work:** Clinton opposes Right-to-Work laws and strongly supports collective bargaining rights for workers.

She believes that unions are critical to providing safe, good-paying jobs for workers so they can provide for their families. She has stated time and time again: "When Unions are strong America is Strong."
